Important Information for Direct Deposit of Tax Refunds

It's important to verify your deposit account information with your tax preparer or your tax software before filing your taxes. For your convenience:

-  Cloverbelt Credit Union's routing number is: 275982283
-  When requesting deposit into your CCU checking account, use the 7-digit checking account number listed on the bottom of your check. This number typically begins with a "2".
-  For deposit to savings, ask any teller or membership services representative.
