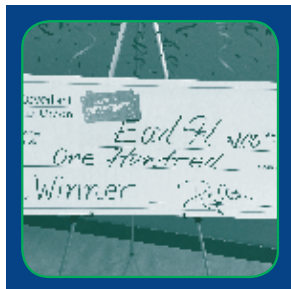

It's important to verify your deposit account information with your tax preparer or your tax software before filing your taxes. For your convenience:

- ☞ Cloverbelt Credit Union's routing number is: 275982283
- ☞ When requesting deposit into your CCU checking account, use the 7-digit checking account number listed on the bottom of your check. This number typically begins with a "2".
- ☞ For deposit to savings, ask any teller or membership services representative.
