In the credit union spirit of “People Helping People” CCU recently participated in donation efforts on behalf of **Molly Viehweg**, the young lady who was critically injured by a hit and run driver in mid-July. Donation jars were available at all locations and we also sold heart-shaped rose quartz stones for \$5.00 each. Rose quartz is called the heart stone and is known for its power for healing and compassion.

Thanks to your generosity, CCU was able to donate \$3,500 to the Molly Viehweg Benefit Fund. All donations will be used to help defray the cost of Molly’s medical treatment and related expenses.

In addition to CCU’s donation, the Wausau Firefighters Community Assistance Foundation offered to sell the heart stones at their recent Corn Hole tournament and raised \$250, which they matched with another \$250 donation (\$500 total). Second Peek Boutique in Wausau also sold over 80 healing stones in their store in Washington Square and contributed \$465, to which they added another \$118 from customers who rounded up their total when making a purchase.
